
**Subject: Amendment of Recruitment Regulations (RRs) for the Group 'C' Posts in Brahmaputra Board- reg.**



**NOTIFICATION**

**GSR .....** In exercise of the powers conferred by sub-section (1) and clause (c) of sub-section (2) of section 29 of the Brahmaputra Board Act, 1980 (46 of 1980), and in supersession of the (i) Ministry of Water Resources, Brahmaputra Board (Group 'C' posts) Recruitment Regulations, 2000, (ii) Ministry of Water Resources, Brahmaputra Board (Group 'C' Canteen Service posts) Recruitment Regulations, 2000, (iii) Ministry of Water Resources, Brahmaputra Board (Group 'D' Posts) Recruitment Regulations, 2000 and (iv) Ministry of Water Resources, Brahmaputra Board Group 'D' Canteen Service Posts Recruitment Regulations, 2000, the Brahmaputra Board with the previous approval of the Central Government hereby makes the following regulation relating the method of Recruitment to Group "C" posts in the Brahmaputra Board, namely:-

1. Short title and commencement: -
  - (i) These regulations may be called the Ministry of Water Resources, River Development and Ganga Rejuvenation, Brahmaputra Board (Group "C" Posts) Recruitment Regulations, 2018.
  - (ii) They shall come into force on the date of their publications in the Official Gazette.
2. Application. - These regulations shall apply to the posts specified in column (1) of the Schedule annexed to these regulations.
3. The Number of said posts, their classification and the Level in the Pay Matrix - The Number of said posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these regulations.
4. Method of recruitment, age limit and other qualifications, etc.- The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (12) of the of the Schedule annexed to these regulations.
5. Disqualification.- No person,
  - (a) who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) who, having a spouse living, has entered into or contracted a marriage with any person,shall be eligible for appointment to the said post:

Provided that the Central government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this regulation.

6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these regulations with respect to any class or category of persons.
7. Saving.- Nothing in these regulations shall affect reservations, relaxation of age limit and other concessions required to be provided for the Schedule Castes, the Scheduled Tribes, Other Backward Classes, ex-servicemen and other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard
