## **“Jal Bachao - Video Banao – Puraskar Pao” Contest**

### **Terms & Conditions**

- Entry into the contest is open to Indian Citizens only.
- The submission of entry is free and no qualifications are prescribed.
- The participant should upload their entry on Youtube and enter the publicly accessible link for the entry using the Video Link icon on the MyGov contest page [www.mygov.in](http://www.mygov.in). Entries submitted through any other medium/mode would not be considered for evaluation.
- The video or advertisement/commercial on water conservation shall capture efforts / significant contributions / best practices used in different parts of the country in field of water conservation, water utilization or water resources development and management.
- The entry must not contain any provocative, objectionable or inappropriate content.
- One entrant can participate only once. Multiple entries from the same entrant shall not be considered and will be discarded.
- The two to ten minute video in Hindi or English or any Regional language must be original and should not violate any provision of the Indian Copyright Act, 1957 or the Intellectual Property Rights of any third party. All entries received by the stipulated date and found in order, shall be evaluated by a Committee constituted by the Ministry. The decision of the Committee would be final.
- The participants will be judged on the basis of elements of creativity, originality, composition, technical excellence, artistic merit, quality of video, content of video and visual impact.
- There will be three winners per fortnight for the competition.
- Prizes for participants :

Prize for winner	:	INR 25,000
Second prize	:	INR 15,000
Third prize	:	INR 10,000
- The winning Videos would be the intellectual property of the MoWR, RD & GR and the winner shall not exercise any right over it. MoWR, RD & GR will have unfettered right to modify the prize winning Video /entry or add/delete any info/ feature in any form to it and shall use them for promotional purposes, Information, Education and Communication materials and also for any other use as may be deemed appropriate.

- Each of the winners will be notified through email address that they provided along with their submission. The myGov portal shall also display the names of winners.
- The prize money shall be transferred through RTGS/NEFT.
- The Government of India, if it so decides, reserves the right not to proceed with the competition at any stage.
- Taxes are the sole responsibility of the teams receiving prizes. Prizes may be subject to tax reporting and other purposes. Participants agree to supply with any necessary information to affect the same and to fully cooperate in fulfilling all applicable legal requirements.
- MoWR, RD & GR reserves the right to cancel or amend all or any part of this Contest and/ or Terms and Conditions/ Technical Parameters/ Evaluation Criteria. However, any changes to the Terms and Conditions/ Technical Parameters/ Evaluation Criteria, or the cancellation of the Contest, will be updated/ posted on the MyGov platform. It would be the responsibility of the participant to keep himself/herself informed of any changes in the Terms and Conditions/ Technical Parameters/ Evaluation Criteria stated for this Contest.
- The participant should make sure that his/her MyGov profile is accurate and updated since MoWR, RD & GR would be using this for further communication. This includes details such as name, photo, complete postal address, email ID and phone number. Entries with incomplete profiles would not be considered.
- All Government employees participating in this competition should have prior permission from their employer to participate in this competition.
- The responsibility to comply with the guidelines and other conditions fully lies with the participant(s) and the Government of India shall not be answerable to any dispute raised by a third party.
- The decision of MoWR, RD & GR in this regard shall be final and shall not be called upon to question under any circumstances.
- Any legal proceedings arising out of the competition/ its entries/ winners shall be subject to local jurisdiction of Delhi State only.
