



No..... -- In exercise of the powers conferred by clause (c) of sub-section (2) of section 29 of the Brahmaputra Board Act, 1980 (46 of 1980), and in supersession of the Ministry of Water Resources, Brahmaputra Board (Group 'A' posts) Regulations, 2013, notified vide No.BB/3202/06/Vol-IV/5 dated 10th December, 2013, the Brahmaputra Board with the previous approval of the Central Government hereby makes the following regulations regulating the method of recruitment to certain Group "A" posts in the Brahmaputra Board, namely:-

1. Short title and commencement.- (1) These regulations may be called the Ministry of Water Resources, Brahmaputra Board, Group "A" Posts Recruitment Regulations, 2018.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. Application.- These regulations shall apply to the posts specified in column (1) of the Schedule annexed to these regulations.
3. The Number of said posts, their classification and the Level in the Pay Matrix - The Number of said posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these regulations.
4. Method of recruitment, age limit and other qualifications: - the method of recruitment to the said posts, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (12) of the Schedule annexed to these regulations.
5. Disqualification.- No person,
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who having a spouse living, has entered into or contracted a marriage with any person,shall be eligible for appointment to the said posts :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this regulation.
6. For the purpose of these regulations the appointing authority for the posts specified in the aforesaid Schedule shall be as given below : -
 - (i) Chairman : For the posts of Director, Deputy Chief Engineer, Deputy Financial Adviser, Superintending Engineer and Deputy Secretary;
 - (ii) Vice Chairman : For the posts in the grade of Executive Engineer (Civil/Mechanical), Assistant Executive Engineer (Civil/Mechanical), Senior Accounts Officer, Accounts Officer, Under Secretary (Establishment), Principal Private Secretary and Assistant Director (OL).
7. Power to relax.- If the Chairman, Brahmaputra Board is of the opinion that it is necessary or expedient so to do, he may, by order, for reasons to be recorded in writing, relax any of the provisions of these regulations with respect to any class or category of persons.
8. Savings.- Nothing in these regulations shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes or the Scheduled Tribes, ex-service men and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
